Entrepreneur Relief

Lifetime limit of chargeable gains should be increased from €1 million to €10 million and the preferential rate of Capital Gains Tax (CGT) should be reduced from 20% to 10% for all qualifying disposals.

This should be made available to all existing and new start-ups so as to encourage investment in Irish businesses.
