## Why Ireland for private equity?

Ireland has become the domicile of choice in respect of the establishment of regulated alternative investment funds ("AIFs") and a centre of excellence in the servicing of alternative investment funds such as private equity funds. Irish service providers and the Central Bank of Ireland have worked to develop solutions to allow the effective and practical implementation of alternative investment strategies in a regulated structure. Ireland is a popular location for private equity funds principally because if its regulatory framework, favourable tax regime, its status as an "on-shore" common law jurisdiction and the availability of excellent legal, audit and administration services.

#### EU and OECD membership

Ireland is a member state of the EU and benefits from the harmonisation of EU financial services regulation and the ability to passport services across the EU. As an EU member state, Irish funds that have Alternative Investment Fund Managers Directive (AIFMD) managers are not subject to the restrictions on marketing imposed by AIFMD on non-EU funds. Ireland further features on each version of the "white-list" of countries published by the OECD setting out countries which have substantially implemented internationally agreed tax standards.

Regardless of the structure of the AIF established in Ireland, Irish funds are exempt from Irish taxation on income and gains derived from their investment portfolios and are not subject to any Irish taxation on their net asset value. Ireland has an extensive and growing network of double taxation treaties providing access to favourable taxation reclaim rates.


